No actions have been taken since June, 2018.

The entire country took note and pride in the Swachh Survekshan 2019 Awards presented by the President of India. Cities have been working steadfastly on cleanliness including upkeep of toilets under ODF⁺ protocol.

However, it is deeply regretted that the headquarter building housing the Swachh Bharat Mission (Urban) itself does not qualify on toilet maintenance protocols, even though the shabby toilet in question, in front of Room. No. 644 A Wing, is maintained by the Director General of Health Services (DGHS). The Photos taken on 7.3.19(attached) need no further description and tollet in question can be safely described as a sickly, unhygienic place. It is indeed irony, as SBM and Health Ministry are working from Nirman Bhawan.

Today, dt. 8.3.19, the problem is more acute, as there is no water supply since morning and those responsible for toilet maintenance, have not taken care either to ensure water supply or LOCK up the toilet. Photo dt.8.3.19 is attached.

It is requested that:

- (1) DGHS may be requested to ensure the cleanliness and serviceability of the toilet at all times and with all fittings and soap etc.
- (2) The Toilet may immediately be taken over by MoHUA for maintenance as majority officers and staff accommodated in the adjacent rooms and premises are belonging to MollUA. Only 4 rooms are with DGHs whereas 13 rooms are with MoHUA.

Ministry of Housing and Urban Affairs is once again requested to resolve this problem urgently, not only for maintaining the health and aesthetics of its officers, but more importantly to sustain the cleanliness movement generated by the SBM.
